- 3) Valley Quarries Base Bid \$165,900.00, Bid Alternate One \$9,450.00, Total \$175,350.00

MOTION: to authorize the issuance of a notice of intent to award to P&W Excavating in the amount of \$129,662.00, condition upon the prior receipt of a commitment letter from the Pennsylvania Department of Transportation for funding through the Pennsylvania Infrastructure Bank was made by Tom Suddeth, second by Jeff Main, all ayes, motion carried.

MOTION: to reserve the right to award the Bid Alternate No. 1 within the required bid timeline, in the event that Peter's Township commits to funding the costs of Bid Alternate No. 1 was made by Donald Stoner, second by Jeff Main, all ayes, motion carried.

MOTION: to approve MMP & W Fire Police to assist with the following: Fayetteville's Carnival and Parade on September 11-14, 2013, Path Valley Parade on August 15, 2013, and Greencastle's Old Home Week Celebration on 8/4, 8/8, 8/9, was made by Tom Suddeth, second by Jeff Main, all ayes, motion carried.

MOTION: to approve Resolution 6-13 for the suspension of two banners to be hung across Main Street from August 20, 2013 until October 4, 2013 was made by Donald Stoner, second by Tom Suddeth, all ayes, motion carried.
