Mr. Stoy recommended the board purchase a HACH unit from Control Systems 21 since LRM does not deal with HACH. LRM is willing to refund the \$5,800, the original cost of the chlorine analyzer in place now. He stated he will be on vacation starting Monday June 21 and he will return Monday, June 28th.

Authority moved onto the Engineer's Report. Lance Hoover reported that he is no longer employed by Dennis E Black Engineering and submitted a new proposal for High Tide Environmental LLC to review. Mr. Hoover went on to state that the authority is now in position to hire an engineer to begin the new plant design. He recommended Glace Associates Inc. Mr. Hoover went on to state that the second round of testing was completed for the Zimm well and it will be submitted to DEP for review. HE also gave a timeline of when the board will need to approve certain items as we move forward with plant design. The PRV pit project will commence the week of July 5th.
